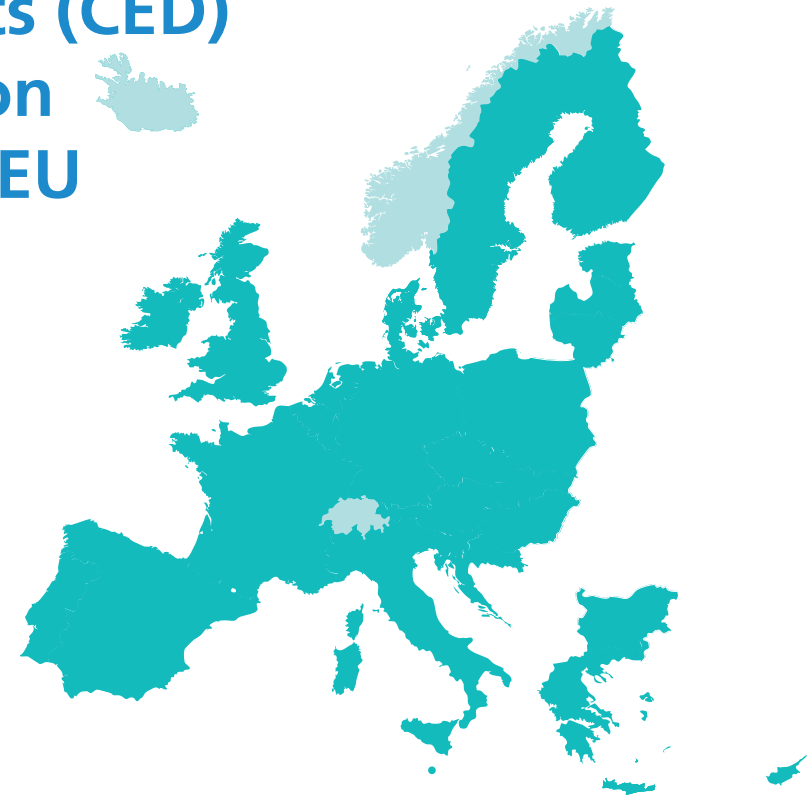


The Council of European Dentists (CED) is the representative organisation for the dental profession in the EU

PRESIDENT'S PERSPECTIVE

The dental profession in Europe has been over the last years increasingly subject to attempts at deregulation and commercialisation. Driven by the twin goals of increasing employment and reducing health expenditure, these pressures are also directly threatening public health.

The Council of European Dentists has long defended independence and professionalism in dentistry, which we believe are best guaranteed by appropriate regulation, and are the basis of dentists' ability to care for our patients. While our positions on professional regulation often clash with the current political climate, a recent decision by the advocate general of the Court of Justice of the

EU gives us hope that the specificity of health professions may yet continue to be recognised.

In an opinion delivered in September 2016, the protection of public health is judged as justifying a ban prohibiting dentists in Belgium from advertising in the same way as other service providers. Healthcare services, and specifically dentistry, are confirmed to differ from other services, and the relationship of trust between the patient and the dentist is seen to be vital for ensuring that patients receive the kind of treatment they need. We are encouraged by this decision and hope that the reasoning will be followed not only by courts but also by politicians across the EU.

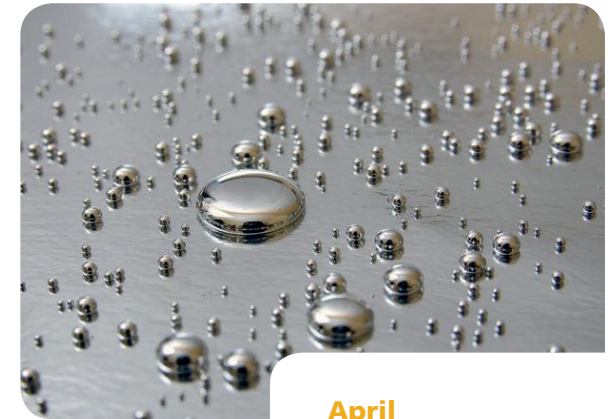

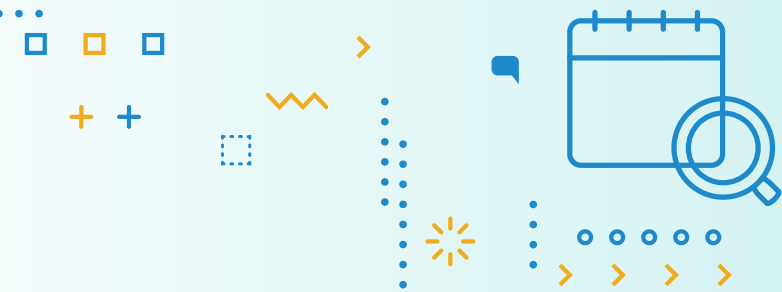

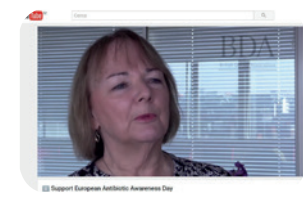

CED Resolution on Annex V.3/5.3.1 of Directive 2005/36/EC (PQD)

The Professional Qualifications Directive (Directive 2005/36/EC) allows dentists from EU countries to have their qualifications recognised and practise across the EU. Following the revision of the Directive in 2013, the CED is proposing changes to the list of study subjects for undergraduate dental education, reflecting developments in dentistry.

AMALGAM

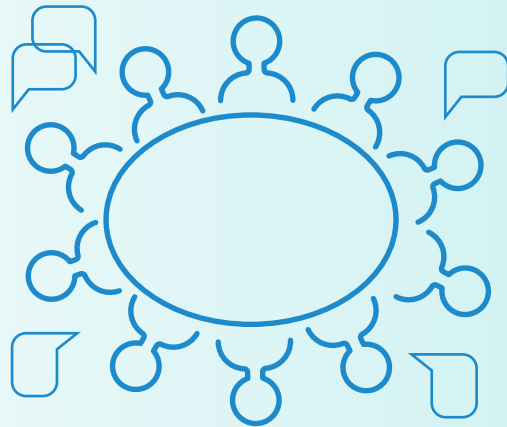
- In 2016, the Working Group continued to work with the European Commission and lawmakers to ensure that the Mercury Regulation, a piece of environmental legislation that aligns the legislative framework in the Member States with the Minamata Convention, does not have a negative impact on oral health of European citizens.
- Throughout these efforts, the CED maintained that dental amalgam is one of a range of well-established, safe and effective restorative materials available to dentists and contributed to a final decision in favour of a gradual phase-down of dental amalgam.
- In 2017, we will follow the Commission's work on assessing the feasibility of phasing out amalgam by 2030.

EDUCATION AND PROFESSIONAL QUALIFICATIONS

- In 2016, the Working Group prepared the revised version of the Resolution on Annex 5.3.1 of the Professional Qualifications Directive that was adopted at the December General Meeting.
- The Group strengthened its collaboration with European dental educators (ADEE) and students (EDSA).
- In 2017, the Group will prepare the update of the CED's profile of the future dentist, monitor developments related to the implementation of the revised Professional Qualifications Directive and continue close cooperation with EDSA and ADEE.

eHEALTH

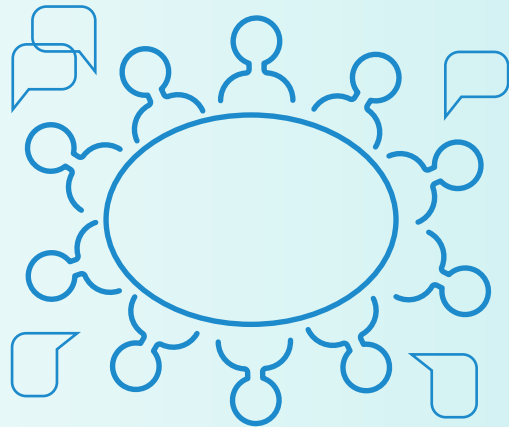
- In June, CED Vice-President and chair of CED Working Group eHealth Dr. Piret Väli spoke at the eHealth Week 2016 in Amsterdam on the impact of eHealth on the practice of dentistry.
- The Group continued contributing to relevant deliverables of the Joint Action supporting eHealth Network (JAseHN).
- In 2017, the Group will reapply to the eHealth Stakeholders' Group and monitor EU initiatives, particularly in the areas of mHealth and under the Digital Single Market Strategy.

INFECTION CONTROL AND WASTE MANAGEMENT

- In 2016, the Working Group continued monitoring EU legislation related to infection control and waste management.
- The Group prepared the CED position on amendments of the Waste Directive and elaborated a statement on waste water disposal for adoption at the December General Meeting.
- The Group also prepared and sent a questionnaire to CED members on the existing national guidance on infection control in dentistry; further work on this is planned for 2017.

MEDICAL DEVICES

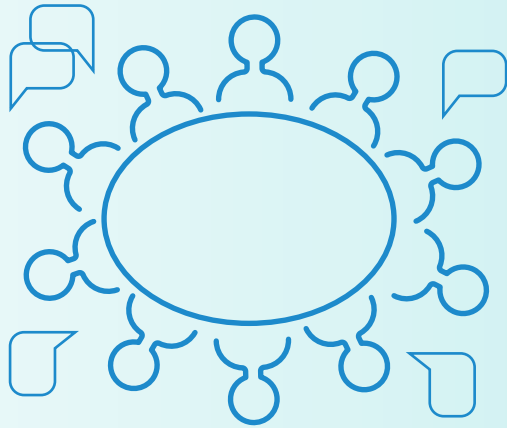
- In 2016, the Group continued following attempts to develop European standards on healthcare services by the European Committee for Standardization (CEN) and reaffirmed the position that healthcare delivery should not be standardised.
- The Group coordinated CED input in the final phase of the adoption of the new Medical Devices Regulation, particularly on issues such as nanomaterials, single use devices, implant cards and Unique Device Identification.
- In 2017, the Group will focus on the impact of implementation of the Medical Devices Regulation on dentistry.

ORAL HEALTH

- In 2016, the Working Group focused on antimicrobial resistance, sugar and integrated care.
- The Group prepared a resolution on sugar that was adopted at the General Meeting in May.
- The Group's mandate was revised in December and during 2017 the Group will pay particular attention to the interplay of oral health and other chronic diseases and explore the impact of integrated care on oral health.

PATIENT SAFETY

- In 2016, the CED contributed to the development of a joint statement by health stakeholders, calling on the European Commission to pay more attention to patient safety and to continue the activities of the Patient Safety and Quality of Care Expert Group.
- In 2017, patient safety will continue to be at the forefront of CED policy. The Group will review our resolutions on patient safety and carry out a survey among our members on national initiatives in patient safety and their impact on dentistry.

TOOTH WHITENING

- In 2016, the CED published the third and final report on undesirable effects of tooth whitening.
- In 2017, we will continue to work with the European Commission on amending the regulation on the use of tooth whitening products on children and young people under 18; we believe that tooth whitening for these patients can be medically justified and safely carried out by a dentist after assessing the individual needs of the patient.

ANTIBIOTICS

- In 2016, the CED contributed to the drafting of EU guidelines on the prudent use of antibiotics by replying to the public consultation and participating in stakeholder workshops on antimicrobial resistance.
- In a regular annual bilateral meeting with the European Centre for Diseases Prevention and Control (ECDC), we reaffirmed our commitment to support the 2016 European Antibiotic Awareness Day campaign.
- CED released a video pledge in which Dr. Susie Sanderson, Chair of CED Board Task Force Antibiotics, recalled the importance of prudent use of antibiotics in dentistry.
- In 2017, we will monitor the delivery of European Commission's Roadmap on Antibiotic Use.

- In 2016, the Task Force prepared the next update to the CED Code of Ethics, a set of guiding principles for professional conduct and ethics throughout Europe first agreed by European dentists in 1965.
- The revised Code of Ethics will be submitted for adoption to the CED General Meeting in May 2017.

INTERNAL MARKET

- In 2016, the Task Force focused on the initiatives of the European Commission on regulation of professions which have the potential to significantly change how our profession is organised and governed across Europe.
- The Task Force contributed to the EU Joint Action on Health Workforce Planning and Forecasting and followed the adoption of the new General Data Protection Regulation.
- In 2017, the Task Force will pay particular attention to maintaining and improving the professional independence of dentists, enhancing their working conditions and mitigating potential negative impact of workforce planning. The proposed proportionality test for new or amended regulation of professions, which the CED believes should not apply to dentists and other health professions, will be of special interest.
